



## PRIVACY POLICY

Children in the Wilderness (CITW) appreciate your support and would like to assure you that we respect your privacy. Should you provide us with any personally identifiable information via our website, associated subdomains and online services, we will make every reasonable effort to keep your information secure. Information you provide to us will be used solely for the purpose of the registered event logistics or described on the page where you enter the information. We have created this security and privacy statement in order to document and communicate our commitment to doing business with the highest ethical standards and appropriate internal controls.

### DATA MINIMIZATION:

CITW undertakes to always only collect information necessary for the required purpose. The information we typically gather, includes:

1. Full Names and Surname;
2. Passport Details (Required for immigration pre clearances at the informal border posts);
3. Travel Insurance and Health details (required for preventative incident management and emergency response);
4. Clothing sizes (required for the event sponsor clothing etc); and
5. Dietary Requirements (required for meal and food preparation planning);

It is important to note that in the planning and execution of events, we utilize specialized 3rd party services, such as caterers, medical professionals, outfitters etc. It may be required for us to share some of your information with these 3rd parties in order to cater for your specific needs or to ensure that our event preparation is up to standard. This may include CITW sharing your medical and health information with our medical staff to ensure that they are prepared in the unlikely event of an emergency, or special dietary information with the caterers in order to ensure that your requirements are met during the event.

Rest assured that these 3rd party service providers are subject to strict confidentiality restrictions and we will only share the relevant information with the applicable service providers necessary to fulfil the purpose.

Information Requests for Fundraising Events and/or CITW:

By completing personal details on the registration platform for an event, all information requested from you will only be used for the purpose of handling fundraising event related matters. This information is also used to get in touch with customers throughout the event planning process, to notify you about products and services that we think will be of interest to you and to run the event logistics with the relevant officials.

PLEASE TAKE NOTE THAT WE WILL SHARE SOME OF YOUR INFORMATION WITH THIRD PARTIES. THIS INCLUDES IMMIGRATION AND CUSTOMS OFFICIALS IN ORDER TO COMPLETE IMMIGRATION PRE-CLEARANCE PROCEDURES AND MANIFESTS, INCIDENT MANAGEMENT, MEAL PLANNING; ACCOMMODATION ALLOCATION ETC.

CITW undertakes to share only the information that is necessary to fulfil the purpose and only to such individuals required to fulfil the purpose.

In the case of making a donation to the CITW Programme, we will have to collect your personal information (first and last name, your credit card details - including card type, card number and expiry date - and your billing address, for example). We will only use your payment details for the purpose of processing your donation.

#### **NEWSLETTERS AND CONTACT:**

CITW will not send you email newsletters at any time, unless you have expressly opted to receive them. All of our newsletters include the option to unsubscribe.

#### **INFORMATION USAGE:**

Like most website operators, CITW collects non-personally-identifying information which web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. The purpose in collecting this type of information is to better understand how our visitors use our websites and to monitor the behaviour of our visitors on our sites. However, we will never disclose personally-identifying information. The information you voluntarily disclose to us, will stay with us. The only exceptions involve disclosure according to an order of a court, for example responding to a subpoena or search warrant, or in the case of you giving your consent us to us to distribute a story about your experiences with CITW.

We do not sell, rent, trade, lend, or otherwise transfer such personal information to affiliates, subsidiaries, sister companies, holding companies, parent companies, strategic partners, or any other organisation.
